## MINUTES OF 2017 ANNUAL GENERAL MEETING

### 2 Approval of Minutes of 2016 AGM

### 4 Reports

**4.1 Chairman's report.** Christine Vince presented her report. She thanked the SW clubs for their support for the Regional and National Championships and competitions, and for running a number of training courses through the year. [\[Appendix 1 to the minutes\]](#)

**4.2 Fixtures Secretary's report.** Richard Sansbury presented his report. The total number of events and activities is slightly more than last year and is predicted to stabilise in coming years. SWOA clubs put on 369 events/activities this year. SWOA continues to play a significant role in putting on national fixtures.

The analysis of the survey of club views on the SWOA fixtures' systems has been sent to clubs and issues raised will be looked at by the SWOA committee with a view

**4.3 SW Junior Squad Manager's report.** Jeff Butt's report was read by Christine Vince. The squad trained on eight weekends. Eleven squad members were selected for Junior Regional Orienteering Squads tours – the highest ever from the south west. A full squad team will attend the Junior Inter Regional Championships 2017. **4.4 Recorder of Controllers' report.** Arthur Vince presented his report. Clubs are reminded that controllers must be licensed by attending the appropriate course, fulfilling the BOF criteria and then must be approved by their club and SWOA. Application forms are available from the Recorder of Controllers. A list of SWOA controllers is posted on the SWOA website. [\[Appendix 4 to the minutes\]](#)

**5 Treasurer and Membership Secretary's report.** Mark Lockett presented his report and the audited accounts for the year 1<sup>st</sup> August 2016 to 31<sup>st</sup> July 2017. [\[Appendices 5 and 6 to the minutes\]](#)

It was noted that:

Grants to juniors for training and competitions amounted to £5918. Grants for volunteer development (courses) amounted to £1658.21 (up on last year). The income from event levies for the year 2016 to 2017 was £8338.70. SWOA has started to outlay money (£435.20) for the 2018 British Sprint and Middle Distance Championships.

SWOA has given £1500 to support the South West Junior Squad activities this financial year. Squad funds at 31 July 2017 stood at £1053.95; provided by Trevor Bridle. [\[Appendix 7 to the minutes\]](#)

The SWOA accounts were audited by Matt Atkins DEVON on 24 August 2017. The accounts were formally approved. Proposed Christine Vince, seconded by Nicholas Maxwell; carried nem.con.

### 6 Membership fees for 2017

The Treasurer proposed that no membership fees be charged for 2017; the levy income is enough to fund SWOA costs. Proposed by Arthur Vince, seconded by Alan Honey; carried nem.con.

## 7 Amendments to the Constitution

Two amendments were proposed:

7.1 Amendment 1: Voting rights for SWJOS Manager and Deputy. New paragraph 2(c)(i). Proposed by Christine Vince, seconded by Alan Honey; carried nem.con.

7.2 Amendment 2: Replacement of paragraph 7 entitled 'Safeguarding' with a new paragraph 7 entitled 'British Orienteering Rules, Regulations and Policies'. It was proposed to omit the new paragraph 7(d); proposed Alan Honey, seconded Christine Vince; carried nem.com. It was proposed to insert the new paragraphs 7 (a), 7(b), 7(c). 9.3 It has been confirmed that Spencer Modica QO will continue as Galoppen Scorer.

9.4 Dick Keighley has agreed to chair committee meetings for the coming year 2017-2018.

The SWOA committee wishes to encourage more Level C events within the region (i.e. more Level D events could / should be run as Level C). The benefits of Level C events are: they carry ranking points; they give officials recordable experience; they should attract more entries. It is felt that we are missing a great opportunity here, particularly for our club officials who wish to move up from Level D to Level C events, and that we should learn to live with two Level Cs at opposite ends of the region.

Thanks to Nath Fernandes for keeping our website up to date.

Thanks to Spencer Modica QO for his hard work scoring the Galoppen series.

Thanks also to Gavin Clegg who has co-ordinated and scored the Summer Relay Series over the past four years. Quite rightly he feels that it is time that someone else had a go, and the job description is in SINS (published on the SWOA website).

The editorship of SINS has now been taken over by yours truly. I cannot hope to emulate Susan Hateley, so it is now a news-sheet rather than a true magazine.

**Fixtures' secretary's report**

My job is to develop an orderly programme of orienteering across the region and to assign major competitions. I do this by frequent liaison with club fixtures secretaries, by representing SWOA on the national Event Scheduling Group and by giving equal opportunity to SW clubs to bid for major competitions.

Over the 12 months from 1 Sept 2016 to 31 Aug 2017 SWOA clubs held a total of 369 events and activities. So almost exactly one a day on average! This is a very impressive total. My thanks to everyone who has contributed to this:

The total is slightly more than last year but it is down on what it was a few years ago. However the decline seems to have stabilised, and we believe that in coming years the numbers will be steady:

We have had no "major" (Level A) events in our region in the past year, nor until today have we had any UK Orienteering League events since last year's Caddihoe. But we are certainly doing our bit for the national programme. In a few weeks DEVON are hosting the CompassSport Cup final, in November BOK are hosting the British Schools Orienteering Championships and next autumn Wimborne have the British Schools Score Championships. This spring the Tamar Triple is now a "national" (Level B) and is included in the UK Orienteering League. In exactly a year's time the British Sprint and Middle Distance Championships will be at Bath University and Stock Hill. Finally plans are under way for the JK which comes to our region in 2021.

This has been my sixth year in the role of SWOA fixtures secretary. After several years in post I thought it would be a good idea to review the fixtures systems by undertaking a survey of what clubs think about fixtures issues. We

undertook this survey earlier in the year and the key findings are:

- As previously mentioned the total number of events is expected to remain steady.
- The main reasons clubs give for not having more events are:
  1. a shortage of available areas, especially for larger events,
  2. a shortage of key officials across the range of events and activities,
  3. fixture congestion at all event levels but especially at local level.
- In response to the key question of whether the current system works well most clubs give a positive, if rather lukewarm, response but some clubs feel it does not work well.

If re-appointed I will be following up on the survey findings over the next year and hopefully we can improve the fixtures systems for clubs and develop good fixtures programmes for the membership.

**Treasurer and Membership secretary's report**

SWOA started the year with a healthy balance of £8568.87 and received income of £9401.67, £8338.70 from Levies and from a returned grant from a cancelled UKCC Level Two course accounting for the majority of the income. Expenditure was £10582.42, over half of this (£5918) was awarded in grants to support SWOA athletes (details below). SWOA also started to outlay money (£435.20) as the organising body for the 2018 British Sprints and Middle Distance Championships. Plans are in place for additional bank account for major events and this will be implemented before the end of the year. SWOA supported the activities of the South West Junior Squad to the tune of £1500 for this financial year. The contribution to the English OC has not been paid as yet and will mean that we will probably need to absorb two payments during 2017/18.

I would like to say thank you to the SW club treasurers, who continue pay levies in a timely manner, 8 of the 9 clubs are now paying by direct transfer. Also thank you to Matt Atkins (Devon OC) for again auditing the SWOA Accounts.

**Proposed amendments to the SWOA Constitution**

**Amendment 1.**

Voting rights for SWJOS Manager and Deputy. It is proposed to insert a new paragraph 2(c) (i) regarding the voting rights for the SWJOS Manager and Deputy. The wording is shown below:

'Where the SWJOS Manager is an elected member of the committee, in the event that s/he is unable to attend a meeting, then the Deputy Manager may attend instead and exercise the associated right to vote.'

**Amendment 2.**

British Orienteering rules regulations and policies. It is proposed to replace paragraph 7 'Safeguarding' with a new paragraph 7 entitled 'British Orienteering rules, regulations and policies'. The wording is shown below:

(a) The South West Orienteering Association agrees to adopt the up to date British Orienteering Policies, Procedures, Rules and Regulations as published on the British Orienteering website.

(b) All individuals involved in orienteering through the South West Orienteering Association in any capacity, are deemed to have assented to and abide by and adhere to the British Orienteering Policies, Procedures, Rules and Regulations as published on the British Orienteering website.

(c) Both the South West Orienteering Association and its members agree to abide by the final outcome of any disciplinary and appeal proceedings.

(d) These clauses replace the clauses published previously and particularly those included in the appendix of O-Safe.

Note. At the AGM 2017 it was agreed to omit new paragraph 7(d).
